We list here a meeting that was part of Indiana Yearly Meeting prior to 1828 if some of the members affiliated with the Hicksite branch after the Separation and kept up that meeting for any length of time.

"FBG" refers to a Friends Burying Ground.

If the Property Corporation Trustees have obtained the original or a copy of a deed, this report has underlined the deed number. If the Yearly Meeting now holds a copy of the instrument in its archives at Wilmington College, we placed a slash behind the underlined number.
